RESOLUTION ESTABLISHING COUNTY SERVICE AREA NO. 18 OF MARIN COUNTY, CALIFORNIA AND DESIGNATING SERVICES TO BE PERFORMED THEREIN

WHEREAS, this Board did on the 3rd day of July, 1973, adopt its resolution of intention to establish a County Service Area under the terms of Chapter 2.2, Part 2, Division 2, Title 3 of the Government Code of the State of California to be composed of that certain territory situate in the County of Marin, State of California, more particularly described in Exhibit "A" attached hereto and incorporated herein by reference, and made a part hereof, and

WHEREAS, this Board did fix Tuesday, the 7th day of August, 1973, at 1:45 o'clock p.m., Supervisors' Chambers, Civic Center, San Rafael, California, as the time and place when and where testimony of all interested persons or taxpayers for or against the establishment of said County Service Area, the extent of the area or the furnishing of specified types of extended services would be heard, and

WHEREAS, the City of San Rafael has consented to the inclusion of incorporated territory within said County Service Area, and

WHEREAS, notice of said hearing was given in the manner and for the time required by Section 25210.16 of the Government Code, and

WHEREAS, at said public hearing this Board did hear any and all protests and objections to the establishment of the area, the extent of the area and the furnishing of specified types of extended services within the area, and

WHEREAS, there were not filed at or prior to said public hearing written protests against the establishment of the area

for the furnishing of recreation and park facilities in the area signed by 50% or more of the registered voters residing within the territory proposed to be included in the area or the owners of 1/2 or more of the value of the land and improvements of the territory proposed to be included in the area as shown by the last equalized assessment roll of the County of Marin, and

WHEREAS, the formation of County Service Area No. 16 has been approved by the Local Agency Formation Commission by Resolution No. 73-10;

NOW, THEREFORE, IT IS HEREBY RESOLVED, ORDERED AND DECLARED:

- 1. That the recitals hereinabove contained are true,
- 2. This Board does hereby find and determine that the following services described in the resolution of intention hereinabove referred to are to be extended county services provided for in County Service Area No. 18.

Local park and recreation facilities and services.

- 3. That there be and it is hereby established within the County of Marin, a county service area to be known as County Service Area No. 18 of Marin County, California, whose boundaries are more specifically described in Exhibit "A" attached hereto and incorporated herein by reference and made a part hereof,
- 4. That the types of services to be performed within said County Service Area No. 18 shall be as follows:

Local park and recreation facilities and services.
