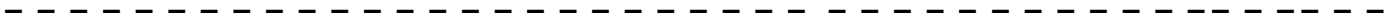
**ACCEPTANCE BY APPLICANT**

The above stated applicant hereby assumes and agrees to protect, hold harmless and indemnify the County of Marin from all legal liability for injury to or death of all persons whomsoever resulting from above said activity. Applicant and organization representatives must be of legal age. Minors may not apply for a permit nor sign the permit application.

**NOTE:** this Special Event Permit and associated park area reservations may be cancelled with minimal notice if government health orders impact the viability of this event. (*Marin County Parks Code 10.01.070 – Closure of lands and facilities*). In the event of such a cancellation, refunds will be issued for the permit application fee, security deposit, and area reservations. The CATX application fee is non-refundable. Marin County Parks and the County of Marin are not responsible for the permit holder’s loss of event revenue or other expenses.
