Reason why Restricted: This product is not currently on our allowed products list.

Reason for Need: Termites are threatening the structural integrity of a field office where staff need to continue to operate safely. Localized treatment will be accomplished by exposing the infested wooded members, using a high- pressure injector, penetrating the wood and exposing the colony to non-repellent termiticide. ATCO uses Termidor HE, active ingredient fipronil, EPA 7969 329 mixed with a foaming agent to reduce drift. Staff will remove or cover pellets (drywood fecal matter) when applicable in accessible areas. Area of treatment must be vacated at time of application. In addition to injecting termiticide as described above, ATCO may apply a borate material. ATCO uses Bora Care, active ingredient Disodium Octaborate Tetrahydrate, EPA 83465-1-64405. This material will protect treated wood against further infestation or infection of wood destroying organisms. Localized treatment comes with a One (1) Year Guarantee. The Structural Pest Control Board requires the following statement: "Local treatment is not intended to be an entire structure treatment method. If infestations of wood-destroying pests extend or exist beyond the area(s) of local treat, they may not be exterminated.

Options/Alternatives: This is the least toxic option available. If this localized treatment is not effective, we will apply for approval to fumigate the building.

Plan to Preclude Future Use: Eliminating this population will prevent the infestation from growing and requiring more intense treatments.

Time Period Needed: 6 months for treatment and follow up monitoring (12/2/20)


